TO REGISTER...

1. Choose a Payment Option:

- Option 1:** Enclose a cheque for \$60 deposit plus extras if applicable, and a second cheque (dated April 30) for the remainder of the total camp fee including applicable taxes.
- Option 2:** Enclose a cheque or credit card number for the total camp fee with taxes, plus applicable extras.
- \$60 is designated as a non-refundable deposit, the remaining balance is refundable up to three weeks prior to the starting date of your child's camp.

 - **Please ensure that your child's full name and camp session appear on the front of your cheque(s).**

2. Complete ALL of the registration form.

- Please note that parents must complete the registration form and not the child.
- Any registration forms received that are not completely filled out with signature and date will not be accepted.

3. If you are registering more than one child.

- Please complete a separate form in full and write **a separate cheque for each child** you are registering.

4. Confirmation will be given by email.

- If you do not have email, you will receive confirmation by phone.
- If you do not receive confirmation by email/phone within 2 weeks of mailing your form, please call the camp office.

GST/HST:

- **According to the information we have received from the government, if you are paying in full before May 1st, you will add only GST to the camper fees and extras. If you are paying after May 1st, you will need to add HST to your camp fees. Please see the chart above.

EXTRAS:

- Tshirts and Hoodies will be provided in the size stated on your registration form, no changes will be made.
